This puppy has been examined by a qualified Veterinarian and has been declared to be in excellent health at the time of this sale and or shipping. This Health Guarantee includes the following: Seller guarantees that as of the date of this agreement puppy/dog is in good health and at the time the puppy/dog was placed on the transport (if shipped). Puppy/dog has received appropriate, deworming's, and is up to date on vaccinations. Seller will provide Buyer with medical information detailing the treatments the puppy/dog has received under the Seller's care. Seller guarantees this puppy/dog until one year of age from the date of purchase of a dog and Date of Birth for a puppy against major life threatening genetic defects that would cause the puppy or dog's death. Seller will not be responsible for any illness or health problems that are diagnosed after this period of time. Buyer must contact Seller/Breeder within 24 hours of diagnosis and return the puppy/dog with all

medical records, laboratory tests, AKC registration and or forms to the Seller as soon as possible. The diagnosis must be supported by a signed and sworn statement by a licensed Veterinarian. The Seller/Breeder reserves the right to retain a second opinion by a licensed Veterinarian to verify major life threatening genetic defect. If a puppy or dog is euthanized prior to the Seller having the option to get a second opinion, this guarantee will be null and void. If the defect is confirmed, the Seller will replace the puppy/dog with another of the same breed, sex, of equal value when one becomes available. If one is not available or will not be coming available of equal value, the buyer will be responsible for any price differences due to bloodlines, markings, etc. In the event of this puppy's/dog's death in the first 12 months, due to a life threatening genetic defect, a necropsy from a state veterinary lab confirming such, and cause is required before the Seller will take any action. In addition, a photo of the deceased puppy/dog must be sent with the necropsy report for I.D. verification. All cost of the above procedures and shipping (returning the puppy/dog incurred by the Buyer are the Buyer's responsibility. The costs of the second opinions are the responsibility of the Seller. A deposit is Nonrefundable nor can it be transferred to another puppy or dog. However, if something happens to the puppy while in my care and cannot be sold, you will have a choice of the next available puppy or a puppy from an upcoming litter. Seller is not responsible for Parvo, Distemper, or any other diseases after the puppy has left my home. Each puppy will have had at least one or two vaccinations before leaving my home. We STRONGLY suggest they the buyer does not take the puppy to any public area or around any other puppies or dogs until ALL vaccinations have been completed. Although we try to predict adult size and color, we do not guarantee either. The following non life threatening conditions are NOT covered in the Health Guarantee nor does the Seller guarantee: Adult size, weight, height, color of coat, quality of coat or ear fringing. Bites, no guarantee on a puppies bite, over or under. Molera (open Fontnal). This should not be considered a flaw as must all open fontanals found in Papillons will close up as the puppy grows. Hydrocephalus, No guarantee after a puppy has left my home. Ears that do not stand erect. During teething, which can last a few months, the ears may go up and down. Taping the ears can be helpful and should be done if you are concerned that they will not become erect. Retained Testicles. We ask that you wait till the puppy is one year and give testicles time to drop. Injury or infection can cause a testicle to be retained. Patella Luxations (knees). Parents have been examined for PL and ALL are clear. Sometimes Patellas's may be loose on a young puppy but will tighten up as the puppy grows. Patella Luxation is commonly seen in ALL toy breeds. Hernias, Worms or Parasites of any kind. Hypoglycemia. Under no condition is the breeder responsible for the loss or death due to hypoglycemia (when blood sugar drops low). Calcium Drops. Seizures and Epilepsy are not life threatening if treated. Coccidia or Giardia. Both are always dormant in the intestines. Many puppies are prone to an outbreak of ciccidia or Giardia under stressful circumstances. Even moving to a new home can cause stress and a drop in their immune system. All precautions have been made, but there is no way to fully prevent it from occurring. The buyer should take the puppy or dog to the vet immediately if they develop runny, smelly, blood in the stool, vomiting or have a loss of appetite. All animals carry Giardia and it can be found in the environment, water and or soil. I do not guarantee Temperament, Disposition or Conformation. I do not guarantee against allergies, skin problems or runny eyes. Breeder is not responsible for any vet bills that occur after puppy or dog has left my home. No refunds on owner allergies, incompatibilities or disagreement among household members concerning the puppy or dog. Seller/breeder will have first option to take

the puppy/dog back. No refund will be given. Sell/breeder will pay for the flight to return puppy/dog. Under NO CONDITIONS will the puppy/dog be taken to an animal shelter or dog pound to be resold or rehomed. Buyer guarantees that he/she will not knowingly offer this puppy to a puppy broker, puppy mill or pet shops. If purchasing a puppy as a "PET" only, you will be required to have your puppy spayed or neutered by 6 months of age before the original AKC registration papers will be mailed to you. The AKC papers will be withheld until notification of altering of animal is received and verified. If you do not spay/neuter your pet this contract will be null and void. Proof of the spay/neuter must be received by the buyer listed here from your veterinarian that the puppy has been spayed or neutered before your AKC papers will be mailed. This is ONLY to protect my dogs from getting into the hands of backyard breeders and puppy mills. Buyer agrees that any puppy purchased from Blue Mountain Papillons have Blue Mountain Papillons as the "prefix" to their registered name. No exceptions. Failure to do so will void this agreement. The puppy/dog must be fed a good quality food. I recommend lamb and rice or chicken and rice. Because of the danger of exposure to outside diseases, Seller reserves the right to refuse the return of any puppy/dog in order to protect the health of my dogs. This contract is valid only for the original purchaser of the dog from Blue Mountain Papillons (Seller/breeder). If the dog is transferred to another owner then this contract is null and void as the Seller has no way of knowing how the dog is cared for or who the puppy/dog is placed with. Buyer also must return signed copy of this contract in order for it to be valid within 10 days from acquiring said puppy. No other guarantees or warranties (written or verbal) are expressed or implied. I also agree that any litigation will be held in Seller's county. In the county of litigation with this guarantee, Seller will be paid reasonable attorney fees by the buyer. This written agreement is the entire agreement between Seller/breeder and buyer of the animal concerning the health and condition of the puppy/dog purchased today. I understand and accept the terms and conditions as stated herein. Both Seller/breeder and Buyer are in agreement by their signatures below.
